ORDINANCE NO. 8804

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 FOR THE LAND-FOR-THE-LANDLESS PROGRAM AND THE MEDICAL EQUIPMENT AND OTHER REQUIREMENTS OF THE OSPITAL NG MAYNILA IN THE TOTAL AMOUNT OF TWO BILLION EIGHT HUNDRED MILLION PESOS (PHP. 2,800,000,000.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the health and safety of its constituents, enhance economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, local government units shall likewise exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes among others the purchase of medical equipment and other hospital requirements to carry out health services and provision for low-cost housing and other mass dwelling (Section 17 of R.A. No. 7160);

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 02, Series of 2022 of the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND THE ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2021 FOR THE LAND FOR THE LANDLESS PROGRAM AND THE MEDICAL EQUIPMENT AND OTHER REQUIREMENTS OF THE OSPITAL NG MAYNILA IN THE TOTAL AMOUNT OF TWO BILLION EIGHT HUNDRED MILLION PESOS (PHP. 2,800,000,000.00)": NOW THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Appropriations. – The FY 2022 Supplemental Budget of the City of Manila in the total amount of Two Billion Eight Hundred Million Pesos (PhP. 2,800,000,000.00) is hereby appropriated to fund the following program and project of the City of Manila, to wit;

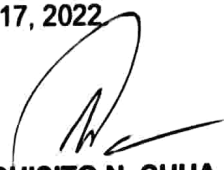

SEC. 2. Separability Clause. – If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.


SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

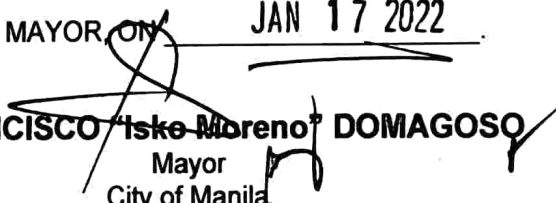
