ORDINANCE NO. 8805

AN ORDINANCE EXPANDING THE PLANTILLA POSITIONS OF THE "BAGONG OSPITAL NG MAYNILA" BY CREATING ADDITIONAL ONE HUNDRED FIFTY (150) VARIOUS NEW PLANTILLA ITEMS TO ACCOMMODATE THE INCREASE OF THE HOSPITAL'S BED CAPACITY TO THREE HUNDRED EIGHTY-FOUR (384) BEDS EFFECTIVE FOR FY 2022, PROVIDING FUNDS NECESSARY THEREOF AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, the City Government of Manila, under the able leadership of His Honor, Mayor Francisco "Isko Moreno" Domagoso, has initiated last year the construction of a 10-storey, 384-bed capacity and fully-airconditioned known as the "Bagong Ospital ng Maynila" Building;

WHEREAS, the PhP. 2.3 Billion health investment of the Local Government is intended to upgrade the facilities of the Ospital ng Maynila Medical Center (OMMC) to world-class standards and to provide better tools and equipment for the city's healthcare workers to meet the present day challenges of caring for Manila's indigent patients;

WHEREAS, this flagship project under the "Build, Build Manila" Program with a total floor area of Twenty-Nine Thousand Nine Hundred Fifty-One Square Meters (29,951 Sq. M.) is scheduled for completion and opening in 2022 and will boast of twelve (12) intensive care units, twenty (20) private rooms, three-storey parking building and a helipad;

WHEREAS, the OMMC needs to dramatically expand its personnel complement to adequately service the increase of its hospital capacity from the present three hundred (300) to the target three hundred eighty-four (384) total beds: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. New Plantilla Positions. – The following new Plantilla items are hereby created under the Ospital ng Maynila Medical Center (OMMC), with particulars as follows:

- SEC. 2. Qualifications, Powers and Dutles/Responsibilities. The qualifications, powers, duties and responsibilities of the afore-mentioned positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.
- SEC. 3. Appointments. The employment and appointment of the individuals for the herein subject positions shall be within the prescribed qualification standards and guidelines set by the Civil Service Commission (CSC) and other relevant agencies.
- SEC. 4. Appropriation. The amount necessary for the creation of the one hundred fifty (150) new regular positions shall be sourced from the Special Activities Fund Personal Services under the FY 2022 Executive Budget. Thereafter, the herein subject positions shall be automatically funded through the succeeding Annual City Budget as part of the Plantilla of Personnel of the Ospital ng Maynila Medical Center (OMMC).
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 20, 2022.
