**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 FOR THE REQUIREMENTS OF THE BASECO COMMUNITY HOSPITAL AND THE INSTALLATION OF SOLAR STUDS IN THE TOTAL AMOUNT OF THREE HUNDRED FIFTY-TWO MILLION TWO HUNDRED NINETY THOUSAND PESOS (PHP. 352,290,000.00) AND FOR OTHER PURPOSES**

## PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the health and safety of its constituents, enhance economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, local government units shall likewise exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes among others health services which includes hospitals and also infrastructure facilities to service the needs of the residents (Section 17 of R.A. No. 7160);

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 03, Series of 2022, of the Executive Committee of the City Development Council on January 24, 2022, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2022 FOR THE REQUIREMENTS OF THE BASECO COMMUNITY HOSPITAL AND INSTALLATION OF SOLAR STUDS IN THE TOTAL AMOUNT OF THREE HUNDRED FIFTY-TWO MILLION TWO HUNDRED NINETY THOUSAND PESOS (PHP. 352,290,000.00)"; NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Appropriations.** – The FY 2022 Supplemental Budget of the City of Manila in the total amount of Three Hundred Fifty-Two Million Two Hundred Ninety Thousand Pesos (Php. 352,290,000.00) is hereby appropriated to fund the following program and project of the City of Manila, to wit;
