## PREAMBLE

WHEREAS, the Damka Tricycle Operators and Drivers Association (DAMKA TODA) of Sta. Mesa, Manila, is a duly registered Non-Stock Corporation at the Securities and Exchange Commission (SEC) on June 22, 2017;

WHEREAS, the Manila Tricycle Regulatory Office (MTRO), likewise certified DAMKA TODA as an authorized Tricycle Operators and Drivers Association (TODA) and was issued with Tricycle Franchise or Certificate of Public Conveyance Authority to Operate (CPCAO) in the City of Manila on September 2, 2019;

WHEREAS, Barangay 598, Zone 59, through its Resolution No. 19, Series of 2017, adopted on November 21, 2017, duly approved the permanent terminals of DAMKA TODA particularly located at the left side of Old Sta. Mesa Street corner of Damka Street up to the Meralco Electrical Post, and from the corner of Old Sta. Mesa Street to the right side going to Damka Street up to the STEVENSHAI Hardware Store: NOW THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** The following are hereby designated as Loading and Unloading areas of the Damka Tricycle Operators and Drivers Association (DAMKA TODA):


**Loading Areas and Unloading Areas:**

1. **Baldovino St. Sta Mesa, Manila beside SM Centerpoint**
2. **Old Sta. Mesa St. corner Damka St. near Sta. Mesa Drug Store**
3. **Old Sta. Mesa St. corner San Lazaro St., Sta. Mesa, Manila**


**SEC. 2. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 31, 2022.
