**ORDINANCE NO. 8813**

**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4 TO FUND THE ADDITIONAL REQUIREMENTS FOR SENIOR CITIZENS ALLOWANCE FOR FY 2021 IN THE TOTAL AMOUNT OF FORTY MILLION PESOS (PHP. 40,000,000.00) AND FOR OTHER PURPOSES**

## PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the health and safety of its constituents, enhance economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, every local government units shall likewise exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes among support for senior citizens (Section 17 of R.A. No. 7160);

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 05, Series of 2022, of the Executive Committee of the City Development Council, entitled "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2022 FOR THE ADDITIONAL REQUIREMENTS OF THE SENIOR CITIZENS ALLOWANCE FOR FY 2021 IN THE TOTAL AMOUNT OF FORTY MILLION PESOS (PHP. 40,000,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Appropriations.** - The FY 2022 Supplemental Budget of the City of Manila in the total amount of Forty Million Pesos (PhP. 40,000,000.00) is hereby appropriated to fund the following program and project of the City of Manila, to wit;






