ORDINANCE NO. 8819

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LEVERIZA M. ADRIATICO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of LEVERIZA M. ADRIATICO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC. (LEATODA), to read as follows:

Loading and Unloading Areas

- a. Manila Zoo, Bangko Sentral ng Pilipinas, Adriatico Suntrust, OSMA, P. Ocampo (Pacific Bldg.) cor. Taft, Harrison (Mabini side) cor. P. Ocampo, Harrison (Adriatico side) Leveriza St.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of LEVERIZA M. ADRIATICO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC. (LEATODA), to read as follows:

LEVERIZA M. ADRIATICO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC. (LEATODA)

135 Units

ROUTE

The authorized route lines of operation shall be via Manila Zoo, Bangko Sentral ng Pilipinas, Adriatico Suntrust, OSMA, P. Ocampo (Pacific Bldg.) cor. Taft, Harrison (Mabini side) cor. P. Ocampo, Harrison (Adriatico side) Leveriza St and vice versa.”


SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


