AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF DELPAN DIST. 1 AND 3 TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of DELPAN DIST. 1 AND 3 TODA INC., to read as follows:

"DELPAN DIST. 1 AND 3 TODA INC.

Loading and Unloading Areas

- a. Delpan St. cor. Tahimik St.
- b. Asuncion St.
- c. Moriones St.
- d. Dagupan St."
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of DELPAN DIST. 1 AND 3 TODA INC., to read as follows:

"ASSOCIATION

RMC

DELPAN DIST, 1 AND 3 TODA INC.

27 Units

ROUTE

The authorized route lines of operation shall be via Delpan St., Asuncion St, Moriones St., Dagupan St. and vice versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
