## ORDINANCE NO. 8821

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF RAON BILIBID VIEJO TRICYCLE OPERATORS DRIVERS ASSOCIATION INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of RAON BILIBID VIEJO TRICYCLE OPERATORS DRIVERS ASSOCIATION INC., to read as follows:

**“RAON BILIBID VIEJO TRICYCLE OPERATORS DRIVERS  
ASSOCIATION INC.**

**Loading and Unloading Areas**

- a. Raon St.
- b. Bilibid Viejo St.,
- c. San Rafael St.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of RAON BILIBID VIEJO TRICYCLE OPERATORS DRIVERS ASSOCIATION INC., to read as follows:

**“ASSOCIATION**

**ROUTE**

The authorized route lines of operation shall be via Raon St., Bilibid Viejo St., San Rafael St., R. Hidalgo St., Arlegui St., Quinta Market, Manila and vice-versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.




