ORDINANCE NO. 8822

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF SAN SEBASTIAN MANILA TODA INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of SAN SEBASTIAN MANILA TODA INC., to read as follows:

"SAN SEBASTIAN MANILA TODA INC.

Loading and Unloading Areas

- a. Legarda cor. San Rafael Street
- b. San Sebastian Street cor. Recto
- c. Plaza Del Carmen cor. Nepomuceno Street"
- **SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of San Sebastian Manila TODA Inc., to read as follows:

"ASSOCIATION

R.M.C.

SAN SEBASTIAN MANILA TODA INC.

39 Units

ROUTE

The authorized route lines of operation shall be via Legarda, Plaza Del Carmen, R. Hidalgo, Concepcion Aguila, Manila."

- **SEC. 3. Separability Clause**. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
