AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF SAN RAFAEL CONCEPCION AGUILA TODA (SRCA-TODA) MANILA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of SAN RAFAEL CONCEPCION AGUILA TODA (SRCA-TODA) MANILA INC., to read as follows:

"SAN RAFAEL CONCEPCION AGUILA TODA (SRCA-TODA) MANILA INC.

Loading and Unloading Areas

- a. San Rafael Street cor. Legarda Street
- b. Mendiola Street cor. Legardac Street"
- **SEC. 2.** Section 2 of Ordinance No. 7871, as amended is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of SAN RAFAEL CONCEPCION AGUILA TODA (SRCA-TODA) MANILA INC., to read as follows:

"ASSOCIATION

R.M.C.

SAN RAFAEL CONCEPCION AGUILA TODA (SRCA-TODA) MANILA INC.)

70 Units

ROUTE

The authorized route lines of operation shall be via San. Rafael St. – Loyola St. – Cayco St., Mendiola St. – Nepomuceno St. – Natividad Lopez St., Manila."

- **SEC. 3. Separability Clause**. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - **SEC. 5. Effectivity Clause.** This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
