### ORDINANCE NO. 8834

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PANAY G. TUAZON B-556 Z-55 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended is hereby furthermore amended, by including therein the loading and unloading areas of PANAY G. TUAZON B-556 Z-55 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

#### Loading and Unloading Areas

- a. Panay G. Tuazon to Blumentritt, España and vice-versa
- b. Panay G. Tuazon to Mangga Avenue

  Stop and Shop, Sta. Mesa and vice-versa"
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of PANAY G. TUAZON B-556 Z-55 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

#### ROUTE

The authorized route lines of operation shall begin in the area of Panay G. Tuazon to Blumentritt, España and back to Panay G. Tuazon to Mangga Avenue–Stop and Shop, Sta. Mesa and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
  - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
