AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ZOBEL ROXAS ESTRADA VITO CRUZ ARELLANO LEON GUINTO SINGALONG TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of ZOBEL ROXAS ESTRADA VITO CRUZ ARELLANO LEON GUINTO SINGALONG TODA INC., to read as follows:

“ ZOBEL ROXAS ESTRADA VITO CRUZ ARELLANO LEON GUINTO SINGALONG TODA INC.

Loading and Unloading Areas

- a. Zobel Roxas St.
- b. Vito Cruz St.
- c. Estrada St.
- d. Zapanta St.
- e. Singalong St.
- f. Arellano St.
- g. San Andres St.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of ZOBEL ROXAS ESTRADA VITO CRUZ ARELLANO LEON GUINTO SINGALONG TODA INC., to read as follows:

“ASSOCIATION

R.M.C.

ZOBEL ROXAS ESTRADA VITO
CRUZ ARELLANO LEON
GUINTO SINGALONG TODA INC.

60 Units

ROUTE

The authorized route lines of operation shall be via Zobel Roxas St. – Estrada St. – Vito Cruz St., Arellano St. – Leon Guinto St. – Singalong St. and vice-versa”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
