AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF RODRIGUEZ DAYAO SALONGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RODASA TODA), INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of RODRIGUEZ DAYAO SALONGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RODASA TODA) INC., to read as follows:

"RODRIGUEZ DAYAO SALONGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RODASA TODA) INC.

Loading and Unloading Areas

- a. Rodriguez-Dayao-Honorio Lopez Blvd. and vice-versa"
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of RODRIGUEZ DAYAO SALONGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RODASA TODA) INC., to read as follows:

"ASSOCIATION

RMC

RODRIGUEZ DAYAO SALONGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RODASA TODA) INC. 50 Units

ROUTE

The authorized route lines of operation shall begin in the area of Rodriguez-Dayao-Honorio Lopez Blvd. and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
