AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LUKBAN BRGY. 671 Z-73 TODA MANILA CITY, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of LUKBAN BRGY. 671 Z-73 TODA MANILA CITY, INC., to read as follows:

“LUKBAN BRGY. 671 Z-73 TODA MANILA CITY, INC.

Loading and Unloading Areas

- a. Angel Linao corner Apacible St.
- b. Calixto Dyco St. corner Alley 2
- c. Syson St. corner Calixto St.
- d. Mahatgande corner U.N. Avenue”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of LUKBAN BRGY. 671 Z-73 TODA MANILA CITY, INC., to read as follows:

“ASSOCIATION

R.M.C.

LUKBAN BRGY. 671 Z-73 TODA
MANILA CITY, INC.

50 Units

ROUTE

The authorized route lines of operation shall be via Apacible St. – Peñafrancia St. – Syson St., Nieto St. – Calixto St. – Belen St. and vice-versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
