ORDINANCE NO. 8839

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BARANGAY 105 ZONE 8 THVT TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of BARANGAY 105 ZONE 8 THVT TODA INC., to read as follows:

“BARANGAY 105 ZONE 8 THVT TODA INC. INC.

Loading and Unloading Areas

- a. Happyland St.
- b. Bldg. 10 Temporary Housing
- c. Bldg. 8 Temporary Housing
- d. Bldg. 12 Temporary Housing”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of BARANGAY 105 ZONE 8 THVT TODA INC., to read as follows:

<u>“ASSOCIATION</u>	<u>RMC</u>
BARANGAY 105 ZONE 8 THVT TODA INC.	70 Units

ROUTE

The authorized route lines of operation shall be via Vitas St. going Velasquez St., to Maginoo St. and vice versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


