AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BRGY. 367 TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of BRGY. 367 TODA INC., to read as follows:

#### "BRGY, 367 TODA INC.

#### Loading and Unloading Areas

- a. Leoner Rivera St. cor. Blumentritt St.
- b. Tecson cor. Felix Huertas St.
- c. P. Guevara St. cor. Cavite St."

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of BRGY. 367 TODA INC., to read as follows:

"ASSOCIATION	RMC

BRGY. 367 TODA INC.

47 Units

#### ROUTE

The authorized route lines of operation shall be via Leonor Rivera St. cor. Blumentritt St. – Tecson cor. Felix Huertas St. – P. Guevara St. cor. Cavite St. and vice versa."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
