AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BLUMENTRITT SILVER TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of BLUMENTRITT SILVER TODA INC., to read as follows:

“BLUMENTRITT SILVER TODA INC.

Loading and Unloading Areas

a. Blumentritt St. corner Andrade St., Sta. Cruz, Manila”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of BLUMENTRITT SILVER TODA INC., to read as follows:

“ASSOCIATION

RMC

BLUMENTRITT SILVER TODA INC.

40 Units

ROUTE

The authorized route lines of operation shall be via Blumentritt St. – Leonor Rivera St. – Antipolo St. – Felix Huertas St. – Malabon St. – P. Guevarra St. – Lope De Vega St. – Oroquieta St. and vice versa, via Blumentritt St. to PNR, LRT Station and vice versa, via Blumentritt St. to SM San Lazaro, Jose R. Reyes Hospital, San Lazaro Hospital, Dr. Jose Fabella Hospital and vice versa.”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
