AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF DECA MALL TRICYCLE OPERATOR AND DRIVER ASSN. INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of DECA MALL TRICYCLE OPERATOR AND DRIVER ASSN. INC., to read as follows:

"DECA MALL TRICYCLE OPERATOR AND DRIVER ASSN. INC.

Loading and Unloading Areas

- a. Vitas St. cor. Jacinto St.
- b. Velasquez beside Deca Mall
- c. Infanta cor. H. Lopez Blvd."

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of DECA MALL TRICYCLE OPERATOR AND DRIVER ASSN. INC., to read as follows:

"ASSOCIATION

RMC

DECA MALL TRICYCLE OPERATOR AND DRIVER ASSN. INC.

70 Units

ROUTE

The authorized route lines of operation shall be via Vitas St., Jacinto St., Velasquez St., Infanta St., Honorio Lopez Blvd. and vice versa."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
