AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ESCODA LEON GUINTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of ESCODA LEON GUINTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

#### **Loading and Unloading Areas**

- a. Leon Guinto St. corner Escoda St., Agoncillo Ct. corner Pedro Gil St. and West Zamora St. corner Burgos St."
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of ESCODA LEON GUINTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

#### ROUTE

The authorized route lines of operation shall be via Leon Guinto St., Escoda St., Apacible St., West Zamora St. and vice versa."
