**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LA TORRE MASANGKAY BENAVIDEZ TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION (LAMABEN TODA), INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of La Torre Masangkay Benavidez Tricycle Operators and Drivers Association (LAMABEN TODA), Inc., to read as follows:

**“LA TORRE MASANGKAY BENAVIDEZ TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (LAMABEN TODA), INC.**

**Loading and Unloading Areas**

- a. La Torre St. corner Masangkay St., Tondo
- b. La Torre St. corner Benavidez St., Tondo
- c. Benavidez St. corner C.M. Recto St., Tondo
- d. Masangkay St. corner C.M. Recto St., Tondo
- e. Masangkay St. corner Luzon St. Sta. Cruz
- f. Benavidez St. corner Luzon St. Sta Cruz
- g. Padre Algue St. corner Jose Abad Santos Ave.
- h. Masangkay St. corner Jose Abad Santos Ave. and vice-versa”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of La Torre Masangkay Benavidez Tricycle Operators and Drivers Association (LAMABEN TODA), Inc., to read as follows:

**“ASSOCIATION**

**R.M.C.**

La Torre Masangkay Benavidez Tricycle Operators and Drivers Association (LAMABEN TODA), Inc.

70 Units

**ROUTE**

The authorized route lines of operation shall be via La Torre St. corner Masangkay St., Tondo – La Torre St. corner Benavidez St., Tondo – Benavidez St. corner C.M. Recto St., Tondo – Masangkay St. corner C.M. Recto St., Tondo – Masangkay St. corner Luzon St. Sta. Cruz – Benavidez St. corner Luzon St. Sta Cruz – Padre Algue St. corner Jose Abad Santos Ave. – Masangkay St. corner Jose Abad Santos Ave. and vice-versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


