AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MOLAVE TONDO TRICYCLE OPERATORS AND DRIVERS ASSN. INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Molave Tondo Tricycle Operators and Drivers Assn. Inc., to read as follows:

"MOLAVE TONDO TRICYCLE OPERATORS AND DRIVERS ASSN. INC.

Loading and Unloading Areas

- a. Molave St. corner Batangas St.
- b. Barrio Roxas corner Batangas St.
- c. Almeda St. corner Batangas St."
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Molave Tondo Tricycle Operators and Drivers Assn. Inc., to read as follows:

"ASSOCIATION

R.M.C.

Molave Tondo Tricycle Operators and Drivers Assn. Inc. 30 Units

ROUTE

The authorized route lines of operation shall be via Molave St. corner Batangas St. – Barrio Roxas St. – Almeda St. going to new Antipolo St. until corner Avenida."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
