**ORDINANCE NO. 8846**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PAZ B-679 Z-74 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of PAZ B-679 Z-74 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

**“PAZ B-679 Z-74 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION,  
INC.**

**Loading and Unloading Areas**

- a. Paz St. corner Pedro Gil
- b. Paz St. corner Sto. Sepulcro St.
- c. Paz St. corner Trece De Agosto”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of PAZ B-679 Z-74 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., to read as follows:

PAZ B-679 Z-74 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC.	62 Units

**ROUTE**

The authorized route lines of operation shall be via Paz St., West Zamora St., Apacible St., Otis and vice versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


