ORDINANCE NO. 8847

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PANAY, ROXAS, CEBU TODA ASSOCIATION INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of PANAY, ROXAS, CEBU TODA ASSOCIATION INC., to read as follows:

“PANAY, ROXAS, CEBU TODA ASSOCIATION INC.

Loading and Unloading Areas

- a. Cebu St. cor. Visayan Ave., Roxas St. cor. Visayan Ave., Panay St. cor. Visayan Ave.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of PANAY, ROXAS, CEBU TODA ASSOCIATION INC., to read as follows:

<u>“ASSOCIATION</u>	<u>RMC</u>
PANAY, ROXAS, CEBU TODA ASSOCIATION INC.	60 Units

ROUTE

The authorized route lines of operation shall be via Roxas Street to Blumentritt – España, and Roxas Street to Piña Avenue (Stop & Shop), Sampaloc, Manila and vice versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
