ORDINANCE NO. 8850

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF UNITED LEALTAD SAMPALOC TRICYCLE OPERATOR AND DRIVERS ASSOCIATION (U.L.S. TODA), INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of UNITED LEALTAD SAMPALOC TRICYCLE OPERATOR AND DRIVERS ASSOCIATION (U.L.S. TODA), INC., to read as follows:

"UNITED LEALTAD SAMPALOC TRICYCLE OPERATOR AND DRIVERS ASSOCIATION (U.L.S. TODA), INC.

Loading and Unloading Areas

- a. Felina, Earnshaw, Loyola and vice versa
- b. Felina/Ma. Cristina, G. Tuazon/Loreto and vice versa"
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of UNITED LEALTAD SAMPALOC TRICYCLE OPERATOR AND DRIVERS ASSOCIATION (U.L.S. TODA), INC., to read as follows:

"ASSOCIATION

RMC

UNITED LEALTAD SAMPALOC TRICYCLE OPERATOR AND DRIVERS ASSOCIATION (U.L.S. TODA), INC. 90 Units

<u>ROUTE</u>

The authorized route lines of operation shall be via Felina/Loyola to Earnshaw/Bustillos Felina/Ma. Cristina to G. Tuazon Loreto and vice versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
