**ORDINANCE NO. 8851**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF KRD-649 TRI-WHEELS INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of KRD-649 TRI-WHEELS INC., to read as follows:

**“KRD-649 TRI-WHEELS INC.**

**Loading and Unloading Areas**

- a. Salas St.
- b. Kalaw St.
- c. Delpan St.
- d. Divisoria Asuncion St.
- e. Anda Circle
- f. Mel Lopez Blvd.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of KRD-649 TRI-WHEELS INC., to read as follows:

**“ASSOCIATION**

**R.M.C.**

KRD-649 TRI-WHEELS INC.

200 Units

**ROUTE**

The authorized route lines of operation shall be via Kalaw – Robinson – Divisoria.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
