AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF KAHILUM, FELIX TRICYCLE OPERATOR AND DRIVERS ASSOCIATION INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of KAHILUM, FELIX TRICYCLE OPERATOR AND DRIVERS ASSOCIATION INC., to read as follows:

“KAHILUM, FELIX TRICYCLE OPERATOR AND DRIVERS ASSOCIATION INC.

Loading and Unloading Areas

- a. Loading – Kahilum I corner Bagong Kalsada to Felix Street (vice versa)
- b. Unloading – Felix Street corner Renaissance and Delas Alas Streets”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of KAHILUM, FELIX TRICYCLE OPERATOR AND DRIVERS ASSOCIATION INC., to read as follows:

ROUTE


The authorized route lines of operation shall be via Macopa, Apitong, Ipil, Bagong Kalsada, Narra, Rosal, Valle, Sampaguita and Felix Streets and vice versa.”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
