AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LEYTE SAMPALOC B-566 Z-55 TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a of Ordinance No. 7755, as amended, is hereby furthermore amended by including therein the Loading and Unloading Areas of LEYTE SAMPALOC B-566 Z-55 TODA INC., to read as follows:

"LEYTE SAMPALOC B-566 Z-55 TODA INC

Loading and Unloading Areas

- a. Loading Leyte St. cor. Visayan St.
- b. Unloading Panay St. cor. G. Tuazon St., D. Santiago St. cor.
 G. Tuazon St., Samar St. cor. G. Tuazon St., Altura St. cor.
 Sta. Mesa St., Batanes St. cor. G. Tuazon St., Leyte St. cor.
 G. Tuazon St., Piña Avenue cor. Sta Mesa St., Manga Avenue cor. Santol St., Blumentritt St. cor. España St."
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of LEYTE SAMPALOC B-566 Z-55 TODA INC., to read as follows;

" ASSOCIATION

R.M.C.

LEYTE SAMPALOC B-566 Z-55 TODA INC.

50 Units

ROUTE

The authorized route lines of operation shall be via Leyte St.- Panay St. – Domingo Santiago St. – Samar St. – Altura St. – Batanes St. – Piña Avenue – Manga Avenue – Blumentritt St."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
