**ORDINANCE NO. 8855**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF STAR BRGY 112 TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of STAR BRGY 112 TODA INC., to read as follows:

**“STAR BRGY 112 TODA INC.**

**Loading and Unloading Areas**

- a. Quezon St. cor. Herbosa St.
- b. Dandan St. cor. Quezon St.
- c. Lacson St. cor. Herbosa St.
- d. Herbosa St. cor. N. Zamora St.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of STAR BRGY 112 TODA INC., to read as follows:

**“ASSOCIATION**

**RMC**

STAR BRGY 112 TODA INC.

100 Units

**ROUTE**

The authorized route lines of operation shall be via Herbosa – Quezon – Dandan – Lacson – N. Zamora and vice versa.”


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


