**ORDINANCE NO. 8856**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF JACINTO ROXAS TONDO TODAMANILA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended is hereby furthermore amended, by including therein the loading and unloading areas of JACINTO ROXAS TONDO TODAMANILA INC., to read as follows:

**“JACINTO ROXAS TONDO TODAMANILA INC.**

**Loading and Unloading Areas**

Roxas Street cor. Jacinto Street”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of JACINTO ROXAS TONDO TODAMANILA INC., to read as follows:

**“ASSOCIATION**

**RMC**

JACINTO ROXAS TONDO  
TODAMANILA INC.

30 Units

**ROUTE**

The authorized route lines of operation shall begin in the area of Jacinto – Roxas – Capulong – Herbosa – Varona – Ugbo – Dayao – Infanta – Rodriguez Ext. – Vitas and vice-versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
