AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF TAMTODA MANILA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of TAMTODA MANILA INC., to read as follows:

"TAMTODA MANILA INC.

Loading and Unicading Areas

- a. M. Natividad Street cor. Tambunting Street
- b. Tambunting Street cor. Blumentritt Street
- c. Cavite Street cor. M. Natividad Street
- d. P. Guevarra Street cor. Leonor Rivera Street
- e. Antipolo Street cor. Blumentritt Streets"

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of TAMTODA MANILA INC., to read as follows:

"ASSOCIATION

R.M.C.

TAMTODA MANILA INC.

40 Units

ROUTE

The authorized route lines of operation shall begin in the area of M. Natividad Street cor. Tambunting Street - Tambunting Street cor. Blumentritt Street - Cavite Street cor. M. Natividad Street - P. Guevarra Street cor. Leonor Rivera Street - Antipolo Street cor. Blumentritt Street and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
