**ORDINANCE NO. 8869**

**AN ORDINANCE** FURTHER AMENDING ORDINANCE NO. 8522, ENTITLED: "AN ORDINANCE CREATING THE CHINATOWN DEVELOPMENT COUNCIL, DEFINING ITS JURISDICTION, FUNCTIONS, DUTIES AND PURPOSE, FOR THE PROMOTION OF CHINESE-FILIPINO CULTURE AND TOURISM IN THE CITY OF MANILA", AS AMENDED BY ORDINANCE NO. 8575

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SEC. 1. RATIONALE.** – The Amendment shall be in reference to Section. 107(b) of the Local Government Code which provides that:

“b) The city or municipal development council shall be headed by the mayor and shall be composed of the following members:

xxx

(2) The chairman of the committee on appropriations of the sangguniang panlungsod or sangguniang bayan concerned”.

**SEC. 2. AMENDMENT.** – Section 3 of Ordinance No. 8522, **as amended by Ordinance No. 8575** is hereby **further** amended **and shall now** read as follows:

**“SEC. 3. COMPOSITION OF THE CHINATOWN DEVELOPMENT COUNCIL (CDC).** – The CDC shall be composed of **thirteen (13)** members and Secretariat.

The CDC Secretariat, headed by the Secretary General, shall be appointed by the City Mayor or his duly authorized representative, who shall act and implement the Resolutions of the Chinatown Development Council. The CDC Secretariat shall also be provided a permanent office/room in Manila City Hall.


The Chinatown Development Council shall be composed of the following members, to wit:

- a. City Mayor or his duly authorized representative who shall act as the Chairman of the Council;
- b. City Planning Officer or his Representative;
- c. Director, Manila Tourism and Cultural Affairs Bureau;
- d. **Chairman, Committee on Appropriations;**
- e. Chairman, Committee on Culture and Arts;
- f. Chairman, Committee on Tourism, City Council, Manila;
- g. An appointed Councilor from District III;
- h. An appointed Representative of the Barangay Chairmen from the Chinatown (Binondo) area;
- i. Representative from the Chinese Business Association;
- j. Representative from the Real Property Owners Association in Chinatown (Binondo) area;
- k. Representative from the Chinese Educational Institutions in Chinatown (Binondo) area;
- l. Representative from the Property Developers and Investors; and
- m. Academic Consultant on Filipino-Chinese Culture and History.”


**SEC. 3. EFFECTIVITY CLAUSE.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 2, 2022.


