AN ORDINANCE IMPLEMENTING THE APPROPRIATE POSITION TITLE AND
SALARY GRADE OF THE CITY VICE MAYOR AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, the current position title and Salary Grade (SG) of the Vice Mayor is City Vice Mayor at SG-29. This was adopted based on the Department of Budget and Management (DBM) letter dated April 26, 1991 of the Secretary Guillermo N. Carague, approving the request for the upgrading of the SG of the Vice Mayor from SG-28 to SG-29;

WHEREAS, the DBM Circular Letter (CL) No. 2007-6 (DBM's Manual on Position Classification and Compensation) dated February 19, 2007 and Local Budget Circular (LBC) No. 137 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government - IOS - LGU) dated July 13, 2021, provided that the position title of the City Vice Mayor is City Vice Mayor II with the corresponding salary grade (SG) of SG-28;

WHEREAS, one of the observations of the DBM in its review of the FY 2022 Annual Budget of the City of Manila, is that: the appropriate position title and SG of an elective official in Special Cities shall be effected upon vacancy in accordance with CL No. 2007-6 and LBC No. 137, of which position is the following, to wit;

WHEREAS, to comply with the DBM review of the FY 2022 Annual Budget of the City of Manila, there is a need to implement the appropriate position title and salary grade of the position City Vice Mayor: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Implementation of the Appropriate Position Title and Salary Grade of the City Vice Mayor Position. - Pursuant to DBM Circular Letter No. 2007-6 dated February 19, 2007 and Local Budget Circular No. 137 dated July 13, 2021, the appropriate position title and salary grade of the City Vice Mayor under the office of the Vice Mayor is hereby implemented as follows:

SEC. 2. Effectivity Clause. - The herein change in the position title and salary grade of the City Vice Mayor position shall be made effective upon vacancy of the incumbent to the said position.


