
AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF VITAS BONIFACIO KATUPARAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (VIBOKA TODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of VITAS BONIFACIO KATUPARAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (VIBOKA TODA) INC., to read as follows:

"VITAS BONIFACIO KATUPARAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (VIBOKA TODA) INC.

Loading and Unloading Areas

- 1. Vitas Street cor. Bonifacio Street
- 2. Bonifacio Street cor. Katuparan Street"
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of VITAS BONIFACIO KATUPARAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (VIBOKA TODA) INC., to read as follows:

"ASSOCIATION

R.M.C.

VITAS BONIFACIO KATUPARAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (VIBOKA TODA) INC.

56 Units

ROUTE

The authorized route lines of operation shall begin in the area of Vitas Street - Bonifacio Street - Katuparan Street and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 23, 2022.
