ORDINANCE NO. 8832

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF DOÑA MARIA TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION (DMTODA), STA. MESA, MANILA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended is hereby furthermore amended, by including therein the loading and unloading areas of DOÑA MARIA TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION (DMTODA), STA. MESA, MANILA, INC. to read as follows:

(DMTODA), STA. MESA, MANILA, INC.**

Loading and Unloading Areas

Doña Maria-Magsaysay-G.Tuazon and vice-versa”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of DOÑA MARIA TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION (DMTODA), STA. MESA, MANILA, INC., to read as follows:

“ASSOCIATION

RMC

DOÑA MARIA TRICYCLE OPERATORS
AND DRIVER'S ASSOCIATION
(DMTODA), STA. MESA, MANILA, INC.

45 Units

ROUTE

The authorized route lines of operation shall begin in the area of Doña Maria, Santol St., Sociego St., Magsaysay St., Altura St., Buenas Aires St., D. Santiago St. and vice-versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.


SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.




