

ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED MILLION THIRTEEN THOUSAND ONE HUNDRED NINETY FOUR AND 81/00 (P100,013,194.81) PESOS OUT OF THE GENERAL FUND OF THE CITY AND THE AMOUNT OF THREE HUNDRED FORTY THOUSAND THIRTY (P340,030.00) PESOS OUT OF THE INFRASTRUCTURE FUND AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 AND INFRASTRUCTURE FUND SUPPLEMENTAL BUDGET NO. 1, RESPECTIVELY, TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATION OF THE VARIOUS OFFICES OF THE CITY GOVERNMENT OF MANILA FOR CY 1988.

BE IT ORDAINED BY THE CITY COUNCIL OF MANILA, THAT:

SECTION 1. There is hereby appropriated from the funds of the City Treasury and from those estimated funds certified as reasonably collectible, and which are not otherwise appropriated, the sum of ONE HUNDRED MILLION THIRTEEN THOUSAND ONE HUNDRED NINETY FOUR AND 81/100 (P100,013,194.81) PESOS out of the General Fund and the amount of THREE HUNDRED FORTY THOUSAND THIRTY (P340,030.00) PESOS out of the Infrastructure Fund, or so much thereof as may be necessary, as General Fund Supplemental Budget No. 2 and Infrastructure Fund Supplemental Budget No. 1, respectively, and which budget documents marked as Annex "A" are attached as integral part hereof, to be made available as additional appropriation of the various offices of the Government of the City of Manila for calendar year 1988.

SECTION 2. The above items of appropriation authorized herein shall take effect on the dates fixed therein for their respective effectivity.


SECTION 3. Within ten (10) days from approval hereof, at least three (3) copies shall be furnished each to the City Auditor and City Treasurer by the Secretary of the City Council in accordance with Section 22 of Presidential Decree No. 477.


SECTION 4. This appropriation ordinance shall take effect upon its approval.

Enacted by the City Council of Manila at its regular session today, June 14, 1988.




