

ORDINANCE NO. 7691

AN ORDINANCE RENAMING THE DON MARIANO MARCOS HIGH SCHOOL IN STA. ANA BY RESTORING ITS ORIGINAL NAME OF MANUEL DE LA FUENTE HIGH SCHOOL.

WHEREAS, the late Mayor Manuel de la Fuente dedicated his selfless leadership to the service of his people;

WHEREAS, during his incumbency as City Mayor of Manila, the late Manuel de la Fuente was instrumental in the rehabilitation and reconstruction of Manila immediately after World War II and once again upholding the tenets of democracy under a regime of peace and progress;

WHEREAS, as a leader of the common man, thru its paternalistic concern he guided the Manila citizenry in proudly standing as free, enterprising and self-reliant;

WHEREAS, during the challenging and critical period of the history of our City, he succeeded in rebuilding physically and morally the City from the debris of the war into a dynamic and progressive metropolis, thus, earning among others the recognition of the police rank and file as the "Manila's Finest" and the distinction of the public schools as the molders of statesmen and business tycoons;

WHEREAS, in recognition and gratitude to the dedicated service of the late Mayor Manuel de la Fuente, a fitting tribute was accorded to him by naming a school in Sta. Ana after his goodself, which was changed to Don Mariano Marcos High School;

WHEREAS, considering the restoration of a free and democratic society it is but deemed proper judicious to give back the due honor and recognition to the memory of the late Mayor Manuel de la Fuente: NOW, THEREFORE, be it

ORDAINED by the City Council of Manila, THAT:

SECTION 1. The name of Don Mariano Marcos High School in Sta. Ana is hereby restored to its




original name of "Manuel de la Fuente High School."

Enacted by the City Council of Manila at its regular session today, November 17, 1988.




