AU ORDINANCE AUTHORIZING ENLINO, INC., REPRESENTED BY 173 PROSTDENT, IR. EL LIO GONZALES LA'O TO OPERATE A MET AND DRY PARCET AT 3991 R. HOU MAGSAYSAY BLVD., STA. MESA, MANTLA UNDER CERTAIN TERMS / ID CONDITIONS.

De it ordained by the City Council of Manila, TMAT:

- Emilio Gonzale La'o is hereby authorized to operate a set and dry market at 599 Ramon Hagsaysay Dlvd., Sta. Hesa, Manila cubject to the following terms and conditions:
 - 1. The grantee shall pay the franchise fee prescribed under Section 44 of the Revenue Code of Manila and for this purpose the books of the grantee reflecting its group receipts shall be made available to the City Treasurer or his duly authorized representative (s) on request:
 - 2. The City shall continue to have and exercise the power to impose all applicable permit and license fees and other service charges upon the grantee and the stallholders licerent in accordance with existing ordinances, rules and regulations.
 - by low to regulate, inspect and supervise the operation of the market to assure compliance with the pertinent rules, ordinances and laws governing markets.
 - 4. The grantee, in order to insure and maintain the income due to the City, shall have the authority to adopt such reasures, impose such charges and penalties and effect such collections as due necessary from the stallholders, conformably with the provisions of existing laws and ordinances.
 - 5. The grantee shall see to it that the administration of the market is done in the most efficient manner, with the end in view of faithfully carrying all the terms and conditions of this grant.
 - 1. In the award of stalls, preferential right shall be accorded the former stallholders in the demolished Sta. Besa Harket and Filipino citizens qualified under the law.
 - 7. The grantee shall abide with the specifications propertible under the existing Norket Code on public workets as well as such rules and regulations as may be promulgated from time to time by competent government authorities.
 - 8. The grantee shall post a continuing bond of P100,000.00 in favor of the City, which penal sum shall be forfeited in favor of the City, as liquidated damages in case of feilure on the part of the grantee to do, perform and comply with any of the terms and conditions set forth herein.
 - 9. That the operational expenses for the said wit and dry market, including the maintenance and cleaning thereof chall be borne by the grantee.
- SEC. 2. The authority granted herein shall be for a period of five (5) years from date of approval.

comply with any of the terms and conditions set forth above shall be a ground for the outright cancellation of the authority, revecation of the permit issued and closure of the market premises.

SEC. 4. his ordinance shall take effect upon its approval.
