ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED TWENTY TWO MILLION THREE HUNDRED TWENTY TWO THOUSAND NINE HUNDRED TUENTY NINE PESOS AND 54/100 (P222,322,929.54) OUT OF THE GENTRAL FUND OF THE CITY AND THE AMOUNT OF FOUR MILLION ONE HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED TWENTY NINE PESOS AND 26/100 (P4,124,229.26) OF THE INFRASTRUCTURE FUND AS THE GENERAL SUPPLEMENTAL BUDGET NO. FUND SUPPLEMENTAL BUDGET NO. 1 AND INFRASTRUCTURE FUND SUPPLEMENTAL BUDGET NO. 1 RESPECTIVELY, TO BE MADE AVAILABLE AS APPROPRIATIONS OF THE CITY GOVERNMENT . OF MANILA TO BE TAKEN FROM THE ESTIMATED ٨S REASONABLY CERTIFIED COLLECTIBLE BY THE CITY TREASURER FOR CY

#### BE IT ORDAINED BY THE CITY COUNCIL OF MANILA, THAT

SECTION 1. There is hereby appropriated from the funds of the City Treasury and from those estimated funds certified as reasonably collectible and which are not otherwise appropriated, the sum of TWO HUNDRED TWENTY TWO MILLION THREE HUNDRED TWENTY TWO THOUSAND HUNDRED TWENTY NINE PESOS and (P222,322,929.54) out of the General Fund and the amount of FOUR MILLION ONE HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED TWENTY NINE PESOS and 26/100 (P4,124,229.26) out of the Infrastructure Fund, or so much thereof as may be necessary as the General Fund Supplemental Budget No. 1 and Infrastructure Fund Supplemental Budget No. 1 respectively, and which budget document marked as Annex "A" is attached and made integral part hereof, to be made available as supplemental appropriations for the City Government of Manila for Calendar Year 1989.

The List of Prior Years' Obligation included under Annex "B" and the List of Repair and Rehabilitation of Fixed Properties presented as Annex "C", are made integral parts hereof.

SECTION 2. Effectivity - This Appropriation Ordinance shall take effect upon its approval.
