AN ORDINANCE PRESCRIBING A NEW SCHEDULE OF FEES FOR LABOR-ATORY EXAMINATION RENDERED BY THE MANILA HEALTH DE-PARTMENT.

Be it ordained by the City Council of Manila, THAT:

- SEC. 2. The Manila Health Department shall collect only one-half of the laboratory examination fees set and provided by this ordinance to any bonafide residents of Manila upon presentation of a certification of his or her "Indigent Status" issued by the Health Center physician or the Social Welfare Administrator of the City of Manila;
 - SEC. 3. All laboratory examination fees collected by virtue of this ordinance shall be paid to the City Treasurer of Manila and shall form part of the General Fund of the City;
 - SEC. 4. All ordinances, resolutions, orders or regulations inconsistent with the provisions of this ordinance are hereby deemed modified or repealed accordingly;
 - SEC. 5. This Ordinance shall take effect upon its approval.
