

AN ORDINANCE REQUIRING ALL LICENSED PAWNSHOPS IN THE CITY OF MANILA TO PAY AN AUCTION PERMIT FEE, PROVIDING PENALTY THEREOF, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. All licensed pawnshops in the City of Manila conducting an auction sale are hereby required to pay an auction permit fee of Three Hundred Pesos (P300.00) per day of auction actually conducted, the amount to be paid to the City Treasurer's Office seven (7) days before the actual auction day. And, in case of postponement of the scheduled day of auction, it will apply to the succeeding day or scheduled day. The effectivity is valid up to the period of three (3) months only, otherwise it has no effect.

SEC. 2. Pawnshops with other branches shall be treated individually and separately and permit issued to a particular branch can not be used by another branch.

SEC. 3. The original copy of the auction permit shall be displayed in a conspicuous place at the pawnshop during the day and time of the auction.

SEC. 4. The permit shall state the following data:

- a). Name of the pawnshop
- b). Business address of the pawnshop
- c). Date and time of the auction
- d). Name of the licensed auctioneer
- e). Auction permit number
- f). Listing of all pawned and/or mortgaged articles for auction with the corresponding pawned value.

SEC. 5. Any person violating any provision of this ordinance shall be punished by an imprisonment of not more than six (6) months or a fine of not more than ONE THOUSAND (P1,000.00) PESOS or both; Provided that in case of a juridical entity, the President or the General Manager shall be held liable thereof.

SEC. 6. This ordinance shall take effect immediately upon its approval.
