

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED EIGHTY FOUR MILLION NINE HUNDRED NINETY TWO THOUSAND NINE HUNDRED SEVENTY EIGHT PESOS and 65/100 (P184,992,978.65) OUT OF THE GENERAL FUND AND THE AMOUNT OF SIXTEEN MILLION ONE HUNDRED FIFTY THOUSAND SIX HUNDRED SIXTY SEVEN PESOS and 74/100 (P16,150,667.74) OUT OF THE INFRASTRUCTURE FUND AS GENERAL FUND AND INFRASTRUCTURE FUND SUPPLEMENTAL BUDGET NO. 1 CURRENT SERIES, TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATION OF THE VARIOUS OFFICES OF THE CITY GOVERNMENT OF MANILA IN IMPLEMENTATION OF REPUBLIC ACT NO. 6753 OTHERWISE KNOWN AS THE COMPENSATION AND POSITION CLASSIFICATION ACT OF 1989.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The amount of ONE HUNDRED EIGHTY FOUR MILLION NINE HUNDRED NINETY TWO THOUSAND NINE HUNDRED SEVENTY EIGHT PESOS and 65/100 (P184,992,978.65) out of the General Fund and SIXTEEN MILLION ONE HUNDRED FIFTY THOUSAND SIX HUNDRED SIXTY SEVEN PESOS and 74/100 (P16,150,667.74) out of the Infrastructure Fund, or so much thereof as may be necessary, is hereby appropriated from the income of the City certified as available by the City Treasurer, as additional appropriation of the various offices of the government of the City of Manila in implementation of Republic Act No. 6758 otherwise known as the Compensation and Position Classification Act of 1989, effective July 1, 1989, including the 13th month differential for the same year.

SEC. 2. SPECIAL PROVISIONS

1. Salaries for Plantilla Positions affected by the implementation of R.A. 6758 otherwise known as the "Compensation and Position Classification Act of 1989" shall be received by incumbents without prejudice to any appeal for reconsideration that might later on be filed.
2. The amount authorized for Plantilla Positions of Departments and Offices in the City of Manila which have remained vacant or unfilled for two consecutive years or more prior to January 1, 1990 shall not be funded under this supplemental budget appropriation ordinance.
3. Salaries for elective officials particularly the Members of the Sangguniang Panlungsod ng Maynila included in the Plantilla for personal services by virtue of R.A. 6758 shall also be without prejudice to any lawful course of action or compensation options that may be availed of by them, in accordance with existing laws, regulations and circulars.

SEC. 3. This ordinance shall take effect upon its approval.
