

ORDINANCE NO. 7758

AN ORDINANCE RENAMING LABORES EXTENSION STREET IN PANDACAN, FROM HILUM STREET TO THE RAIL ROAD TRACK, IN THE SIXTH DISTRICT OF MANILA TO "LIBRADA M. AVELINO STREET."

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Labores Extension Street in Pandacan, from Hilum Street to the rail road track, in the Sixth District of Manila is hereby renamed "Librada M. Avelino Street."

SEC. 2. The City Engineer is hereby directed to install or cause the installation of the corresponding street signs in strategic places thereto.


SEC. 3. This Ordinance shall take effect upon approval.


