

ORDINANCE NO. 7759

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY NINE MILLION EIGHT HUNDRED SIXTY THREE THOUSAND TWENTY TWO PESOS (P29,863,022.00) OUT OF THE PAGCOR TRUST FUND TO BE MADE AVAILABLE AS APPROPRIATIONS FOR THE CONSTRUCTION, IMPROVEMENT AND REPAIR OF PUBLIC DRAINAGE SYSTEMS AND RELATED INFRASTRUCTURE PROJECTS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. It is the policy of the City of Manila that funds kept in the Treasury from the financial assistance of the Philippine Amusement and Gaming Corporation be appropriated for lawful projects and purposes.

SEC. 2. The amount of TWENTY NINE MILLION EIGHT HUNDRED SIXTY THREE THOUSAND TWENTY TWO PESOS (P29,863,022.00) is hereby appropriated out of the PAGCOR Trust Fund existing in the Treasury certified by the City Treasurer as available for appropriation for the construction, improvement and repair of public drainage system and related infrastructure projects.

SEC. 3. For purposes of implementation, the funds herein appropriated shall be allocated equitably and equally to the six (6) legislative districts of the City of Manila and the funded projects, shall conform to the guidelines set by the Philippine Amusement and Gaming Corporation.


SEC. 4. This Ordinance shall take effect upon approval.
