

ORDINANCE NO. 7762

AN ORDINANCE RENAMING CAMARINES STREET FROM FELIX HUERTAS STREET TO THE ESTERO IN STA. CRUZ, THIRD DISTRICT OF MANILA, TO "SATURNINO C. HERRERA STREET."

Be it ordained by the City Council of Manila, that:

SECTION 1. Camarines Street from Felix Huertas Street to the Estero in Sta. Cruz, Third District of Manila, is hereby renamed "Saturnino C. Herrera Street".


SEC. 2. The City Engineer is likewise directed to install or cause the installation of the corresponding street signs in the strategic places thereto.


SEC. 3. This Ordinance shall take effect upon approval.


