

ORDINANCE NO. 7766

ORDINANCE REQUIRING OPERATORS OF PEDICABS AND TRICYCLES-FOR-HIRE TO COMPLY WITH THE COLOR SCHEME PROVIDED HEREIN, IMPOSING PENALTIES THEREOF, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Operators and/or owners of pedicabs and tricycles for hire, are hereby required to paint their units to conform with the herein prescribed color scheme:

- First District - Blue
- Second District - White
- Third District - Green
- Fourth District - Orange
- Fifth District - Yellow
- Sixth District - Red

SEC. 2. The Bureau of Permits shall be responsible for implementing Section 1 of this ordinance.

SEC. 3. All pedicabs and tricycles for hire shall not be allowed to register and/or operate without the necessary color scheme.


SEC. 4. Any violation of this ordinance shall be punishable by a fine of P500.00 to P5,000.00 and/or 3 months imprisonment, or both, upon the discretion of the court.


SEC. 5. This ordinance shall take effect upon approval.
