

AN ORDINANCE INSTITUTING AN EDUCATIONAL PROGRAM ON COMMUNITY SAFETY MEASURES AMONG PUBLIC ELEMENTARY STUDENTS IN THE CITY OF MANILA, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy - The maintenance of peace and order is a primordial concern of the City Government of Manila.

In order to ensure a stable peace and order condition, the City Government shall enhance and strengthen the cooperation between its officials and the people of Manila.

SEC. 2. The Western Police District Command and the Fire District I of the City of Manila are hereby mandated to establish and develop an educational program on public safety measures geared towards training public elementary students in the City of Manila.

SEC. 3. In the establishment and implementation of this program, the Division of City Schools of Manila, shall coordinate with the Western Police District and the Fire District I and the latter agencies shall seek the technical assistance of the Philippine Public Safety College of the Philippine National Police.

SEC. 4. Coverage of the Program - The educational program shall include, but shall not be limited to, public welfare and safety; protection of lives and properties; and maintenance of the stability of the Local Government Unit against the inroads of insurgency, subversion and other lawless or criminal activities.


SEC. 5. Details of Implementation - The Western Police District and the Fire District I in coordination with the Division of City Schools of Manila and the Philippine Public Safety College, shall formulate and establish the implementing details of this program consistent with the provisions of this ordinance.


SEC. 6. Effectivity - This Ordinance shall take effect immediately upon its approval.

Enacted by the City Council of Manila at its regular session today, November 17, 1992.


