

ORDINANCE NO. 7781

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE SPO3 REYNALDO CASTRO, PO3 DANILO DIMAANDAL, PO3 DAMASO RIVERA AND POLICE MAJOR RAMON PADRE, ALL MEMBERS OF THE WESTERN POLICE DISTRICT COMMAND (WPDC), IN RECOGNITION OF THEIR ACTS OF BRAVERY AND GALLANTRY, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy - It is the declared policy of the City Government of Manila to recognize exemplary deeds of men in uniform to serve as inspiration and to foster among them the highest ideals of public service.

Towards this end, grants of financial assistance to the members of the WPDC specified in Section 2 becomes expedient as a modest gesture of the City Government to inspire the other members of the Command and foster among them the highest ideals of public service.


SEC. 2. The amount of TWO HUNDRED THOUSAND (P200,000.00) PESOS is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the grant of financial assistance of FIFTY THOUSAND (P50,000.00) PESOS to the family of the late SPO3 Reynaldo Castro and TWENTY FIVE THOUSAND (P25,000.00) PESOS each to PO3 Danilo Dimaandal and PO3 Damaso Rivera in recognition of their acts of bravery and gallantry shown during the robbery-holdup incident last 21 September 1992 at Ermita, Manila, and ONE HUNDRED THOUSAND (P100,000.00) PESOS to Police Major Ramon A. Padre who was shot and seriously wounded during a hostage-taking incident in 1985 in Moriones, Tondo, which resulted to quadriplegia or total paralysis of his body.


SEC. 3. Effectivity - This Ordinance shall take effect immediately upon its approval.
