## ORDINANCE NO. 7187

AN ORDINANCE ALLOWING THE USE OF TWO HUNDRED EIGHTEEN POINT SEVENTY FIVE SQUARE METERS (218.75 sq. m.) LAND OWNED BY THE GOVERNMENT, LOCATED ALONG ZAMBALES STREET, BETWEEN M. HIZON AND FELIX HUERTAS STREETS, IN BLUMENTRITT, STA. CRUZ, MANILA FOR THE BENEFIT OF ERIBERTO REMIGIO PRIMARY SCHOOL.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. <u>Declaration of Policy</u>. - It is hereby declared that it be the policy of the City Government to give paramount importance to education through assistance to improve the quality of education in the City.

SEC. 2. <u>Authorization</u>. - It is hereby authorized that the land owned by the City Government consisting of two hundred eighteen point seventy five square meters (218.75 sq. m.) located along Zambales St. between M. Hizon and Felix Huertas Sts. in Blumentritt, in Sta. Cruz, Manila, be used for the benefit of Eriberto Remigio Primary School located also in the same area mentioned, the same to be used as site for the construction of a new school building in consonance with the upgrading of the school's facilities.

SEC. 3. Effectivity. - This Ordinance shall take effect fifteen (15) days after approval and publication in newspapers of local circulation.
