## ORDINANCE NO. 1793

AN ORDINANCE REQUIRING ALL ADMINISTRATORS, OWNERS AND OPERATORS OF PUBLIC OR PRIVATELY OWNED OR OPERATED MARKETS TO POST IN FOUR CONSPICUOUS PLACES, THE PRICE LIST OF BASIC COMMODITIES, INCLU-DING FISH AND MEAT PRODUCTS.

SECTION 1. All administrators, owners and operators of public or privately owned markets are hereby required to post in four conspicuous places the price list of basic commodities, including fish and meat products.

- The price list which shall be posted daily shall be prepared by the market master in case of a public market or the market administrator in case of a privately owned market.
- SEC. 3. Repealing Clause. All ordinances, rules and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed, amended or modified accordingly.
- SEC. 4. Penalty Clause. Any person violating this ordinance shall, upon conviction, be penalized by imprisonment of not more than 6 months and/or a fine of not more than P2,000.00.

Effectivity Clause. - This ordinance shall take effect SEC. 5. upon its approval.
