

ORDINANCE NO. 7799

AN ORDINANCE RENAMING BALASAN STREET IN THE FIRST DISTRICT OF MANILA TO PEDRO P. ALFONSO STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Balasan Street in the First District of Manila is hereby renamed **PEDRO P. ALFONSO STREET**.


SEC. 2. The City Engineer is hereby directed to replace or cause the replacement of the present street signs installed in strategic places thereat.


SEC. 3. This Ordinance shall take effect upon its approval.
